## REGULATORY GUIDELINES FOR SENDING PAPERS AND POSTERS

- The objective of this call is to contribute to raise awareness of Social Economy and each of the different business models.
- Papers and/or posters related to the following topics will be accepted:
  - I. Rural Environment and Social Economy.
  - II. Artificial Intelligence and Social Economy.
  - III. Networking in Social Economy.
  - IV. People, Talent and Professional Development in Social Economy.
- Papers and/or posters must comply with the standards contained in these guidelines (size and font, content, length, etc.). Failure to comply with this requirement may result with the paper being rejected, specifically:
  - Font and type: the text must be in Arial font, point 11
  - Include 4-6 keywords
  - References: References defined in the text must be numbered and written in Arial point 8.
  - Length: maximum 500 words (including the abstract).
- Presentations are structured according to the following questions:
  - I. The main problem(s).
  - II. The methods/approach used.
  - III. The results.
- Papers and/or posters may be presented individually or in collaboration with other authors. There is a limit of two authors per paper and/or poster, with the first or second author must be registered for the conference (if accepted). Failure to meet this requirement will result in the paper and/or poster being rejected.
- Papers and/or posters may be presented in Spanish or English.

- A Technical Committee will evaluate the different communications and/or posters received. This committee will be composed by six people, four of whom will be members of the ASECYL Board of Directors and/or its partner organizations, and two of whom will be professionals from the sector.
- The Technical Committee will be appointed and chaired by the president of ASECYL and must include at least one representative from the various Social Economy families that comprise ASECYL.

**DEADLINE FOR SUBMISSION OF PAPERS AND POSTERS:** August 14th, 2025, at 11:59 p.m. (email entry time will be taken into account)

**FORMAT FOR PAPERS AND POSTERS:** Template attached to these rules, in Word format.

The Technical Secretariat of the Congress will communicate the correct reception of the Communication and/or posters, and that it complies with these rules.

## EVALUATION OF COMMUNICATIONS AND POSTERS:

The following aspects will be taken into account when evaluating papers and/or posters

- Originality, scientific interest, methodology used, clarity in the presentation of results and conclusions and the grammatical style of writing.
- The Technical Committee may request information and/or clarification from the author(s) before issuing a final evaluation. Failure to respond on time to the request, will result in the non-acceptance of the paper and/or poster.
- Each submitted paper and/or poster will be evaluated independently by each member of the Technical Committee, scoring 1-10, with 10 being the highest. The paper and/or poster will be assessed based on the average score of each of the votes received from the members of the Technical Committee.
- The results of the evaluation will be communicated to each author before September 5<sup>th</sup>, 2025, whether accepted or not.

**ACCEPTANCE OF THE COMMUNICATION AND POSTER:** If the communication and/or posters are accepted, the following issues must be taken into account:

- The public presentation of the paper and/or poster, in the Congress forum, will take place on November 11<sup>th</sup>, 2025 (second day of the Congress)
- It's mandatory to attend the conference in person to present the paper, allowing 15-20 minutes for its presentation.
- It's essential to be present with the poster for its public presentation on the designated day.
- Papers and/or posters may be presented in Spanish or English.
- Travel, accommodation, and subsistence expenses will be paid by the speaker.
- If you cannot accept these conditions, please notify us before September 10<sup>th</sup> to allow us to include a new paper and/or poster.
